SWC is a nonprofit public benefit organization which means it is a charitable organization that is advantageous to the general public. History of SWC

The SWC organization began approximately 36+ years ago. On March 25th, 1991, the Secretary of State filed the Articles of Incorporation, for SWC to become a nonprofit public benefit organization.

The Articles of Incorporation state that the specific purpose of this corporation is to educate the general public in, and promote the development of choral music and other art forms through concerts and community performances.

This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.

Achievements for 2023

Recruited and hired Dr. Cindy Chaffee as an Associate Director to create an ensemble, now known as Inner Harmony. The ensemble consists of up to 16 members of the SWC and is available to perform at more events than the full chorus. Inner Harmony had their premier performance at the Fall 2023 Concert at the El Camino Performing Arts Center.

Recruited and hired Michelle Casciato for the purpose of increasing fundraising. She exceeded her first-year goals and implemented a successful End-of-Year Holiday Campaign as well as established an active database of donors.

Purchased new risers for the chorus.

Provided two scholarships in the amount of \$1,000 each to applicants that were in Fine Arts programs and identified as female students at Mira Loma High School and a student at El Camino High School.

Due to a vacancy of the Artistic Director, advertised, recruited, and hired a qualified candidate.

Receive a grant from the City of Sacramento Arts and Cultural Covid Recovery Program to off-set some personnel expenses.

On August 8, 2023, the Board of Directors approved renaming the Scholarship Fund to the "The Sacramento Women's Chorus Jean Schultz Memorial Scholarship" fund.

Some chorus members performed as a partner with the Sacramento Gay Men's Chorus.

The Board and Team Leads attended Leadership Training session.

The SWC Annual Meeting was held on October 30, 2023, to elect new Board members for the 2024-2025 years. The Board and chorus also approved an updated a portion of the by-laws.
